Rough-Housing

With play comes inherent rough-housing. I understand there are risks and benefits associated with group socialization of dogs. I understand that while the socialization and play is closely monitored by Paws 'N' Play Doggy Daycare staff to prevent injury, it is possible that during the course of normal play my dog(s) may receive minor injuries from rough-housing with other dogs.

In the event a fight or injury does occur, we will do our best to contact you to bring your dog to your vet, or we will bring them to the vet and bill you for the fees. We will always attempt to contact the owner or emergency contact prior to providing any medical attention.
